## Our guest speaker for May

Daniel Miller is a sixth-generation Texan, a technology consultant, a best-selling author, and President of the Texas Nationalist Movement (TNM). As an outspoken advocate for Texas independence since 1996, Daniel is considered the founder of the modern-day TEXIT movement.

Daniel has been involved in the technology industry in Texas since the mid-1990s. He currently works as a freelance technology consultant for small to medium-sized companies and startups. He also operates Radio Free Texas, a digital music platform focused on Texas music, with his wife, Cara.

In 2005, Daniel founded the Texas Nationalist Movement, an organization dedicated to the political, cultural, and economic independence of Texas. In that time, as the organization's President, the TNM has grown to become one of the largest political advocacy organizations in Texas and one of the largest independence advocacy organizations in the world. Representing the TNM, Daniel has testified on many pieces of legislation and is a regular fixture at the Capitol during the legislative session. As a result of the success of the TNM, Daniel has become a sought-after expert at conferences and meetings in Texas, the rest of the United States, and internationally on the issue of self-determination.

In 2011 he authored *Line in the Sand*, his first book, which addresses the roots of Texas Nationalism and the practical implications of national self-identity as Texans. In 2018, Miller released *TEXIT: Why and How Texas Will Leave The Union*, a four-time bestseller and considered the ultimate guide to Texas becoming a self-governing, independent nation. *TEXIT* covers the motivations behind the modern movement for Texas independence and lays out a practical path to achieving it.

## Our Mission

The mission of the Republican Club of Comal County is to promote “Faith, Family, and Freedom” by providing information and education about critical political issues, by encouraging active participation in the political process, by supporting conservative Republican nominees, and by fostering loyalty to the Republican Party and its conservative ideals.

### **The Republican Contract with America, 2022**

- 1) A Safe and Law-Abiding America. Crime prevention and punishment is mostly a local and state affair. But the federal government promises to prosecute fully any criminal who crosses state lines or uses interstate communications to commit arson, public destruction, smash-and-grab looting, or general attacks on any federal property within the states.
- 2) Affordable Energy for an Energy-Independent America. Restoration of gas and oil energy independence; reopening of federal lands for new energy leases; fast-tracking natural gas and oil pipelines; encouragement and incentives to mine rare and precious metals inside the United States needed for batteries and new sources of energy.
- 3) A Secure Border. Immediate completion of the border wall. Deportation of all those who crossed illegally between 2017 and 2024 and all criminals convicted of felonies or serious misdemeanors; employer sanctions; an end to catch-and-release; all refugee seekers apply outside the United States; a tax on remittances sent south of the border on those here illegally and on public assistance; the end of the primacy of family considerations in fast-tracking immigration requests, replaced by meritocratic considerations of English facility, skill sets, and education. All immigration would be predicated on legality, diversity, meritocracy, and measured and manageable numbers necessary for assimilation and integration.
- 4) A Sacrosanct Constitution and Preservation of Long-Held Traditions. On record for no changes to the Constitution; no dismantling of the Electoral College; no federalization of states' voting laws; no increase in a nine-justice Supreme Court; no statehood for Washington, DC, and Puerto Rico; no end to the Senate filibuster.
- 5) The Restoration of Election Day. Encouragement to the states to limit mail-in balloting, return to the old notion of absentee balloting as an exception rather than the norm, and cut back on extended/early balloting — with the goal that 60 to 70% of ballots cast are done so on Election Day.
- 6) A "Don't Tread on Me" Foreign Policy. Strong support for the sanctity of allied nations. Deterrence against Russia, China, Iran, North Korea, and other belligerents. A realistic foreign policy of "No better friend, no worse enemy." An end to optional large, on-the-ground military engagements in the Middle East. A return of Pentagon emphasis on battle readiness rather than social justice and woke agendas, with budgets redirected to missile defense and naval and air deterrence.
- 7) Towards a Balanced Budget. Expenditures must match revenues. An update of the Simpson-Bowles National Commission on Fiscal Responsibility and Reform or enactment of its recommendations, with the aim of achieving a balanced budget in four years.
- 8) Anti-Trust, Anti-Monopoly Legislation. An end to Silicon Valley's vast monopolies, cartels, and immunity from public-utility regulations.
- 9) Strict Enforcement of the Civil Rights Act of 1964. Prohibition of the use of racial bias/advantage/preference in the operations of public local, state, and federal agencies. No federal funds allotted for critical-race-theory indoctrination.
- 10) No Federal Funds for Lawbreakers. An end to federal support of state agencies and private institutions that violate federal statutes and the Bill of Rights, whether sanctuary-city jurisdictions or campuses whose speech and trial codes violate the First, Fourth, Fifth, and Sixth Amendments. Loss of tax-free status on income from university endowments of more than \$10 billion.

## An Open Border With Free Healthcare

Americans are a generous and welcoming lot, but Biden's flouting the Rule of Law is insulting.

Despite some recent feigned attempts at toughness, Joe Biden's border is still wide open, and the intentional invasion continues apace. In fact, Mr. Moderate Biden continues to find ways to move to the left.

U.S. Customs and Border Protection has reported more than 5.1 million apprehensions at the border since January 2021, and that's not including numbers from March. We do know there have been a record 24 consecutive months with apprehensions surpassing 150,000, and in 12 of those months it was more than 200,000.

Biden rolled out the red carpet as a candidate for president, even openly telling anyone seeking asylum, "You should come." He has kept his promise to fling the door open wide, and the response has been predictable. As our Thomas Gallatin put it last month, "Directing the flow of migrants rather than stopping it has become his administration's main border goal."

Donald Trump largely stemmed the flow of illegal aliens into the country, including establishing Title 42 as a means of quickly expelling illegal border crossers during the pandemic. After trying unsuccessfully to get rid of Title 42, Biden has shifted to just granting everyone an exception to it.

The Biden administration in January expanded the CBP One app so as to help facilitate migrants' arrival by granting humanitarian exceptions to Title 42. It has been working exactly as intended — making more border crossers legal. In fact, Fox News reports, "The overwhelming majority of requests made by migrants for an exception to the Title 42 public health order using the recently-expanded CBP One app have been accepted, with 99% of migrants being found to have met the criteria."

Fox adds, "More than 75,000 applications have either been carried out or scheduled until April 25." And once those appointments and exceptions are granted, migrants are usually released into the U.S. with a Notice to Appear. Let's just say not all of them do.

"It's like a concierge service for illegal immigrants," said Missouri Republican Senator Josh Hawley last month. Moreover, now that Biden reluctantly signed legislation officially ending the COVID emergency, Title 42 soon won't even be a pretense in his way. Indeed, perhaps 40,000 migrants have gathered at the border ready to surge across once Title 42 is gone, and even the administration predicts that CBP encounters could reach 400,000 a month.

And why wouldn't there be a surge? Biden's other latest ploy is to build upon Barack Obama's unconstitutional Deferred Action for Childhood Arrivals (DACA) program to legalize illegals brought here as children by using another executive order to make those estimated 580,000 people eligible for Medicaid and ObamaCare. Congress declined to pass a law regarding the so-called Dreamers, so Obama did it anyway. Congress explicitly excluded illegals from government healthcare entitlements, so Biden is going to grant access anyway.

Remember that time Representative Joe Wilson yelled "You lie!" at Obama during the former president's speech to Congress? Well, it was when Obama claimed it was "false" to say his "reform efforts would insure illegal immigrants."

Turns out Wilson was right all along, and Biden is the one making sure of it.

"President Biden and Vice President [Kamala] Harris believe that health care should be a right, not a privilege," said the White House in a statement. Biden added in a video of DACA recipients, "They're American in every way except on paper." That "paper" happens to represent the Rule of Law. The Constitution is a piece of paper too, and Biden routinely rips it to shreds.

Biden and his Democrat pals do this so they can paint Republicans as "anti-immigrant." They create a humanitarian crisis of millions of people smuggled in by criminals and then they claim Republicans are the problem.

That is a lie.

The vast majority of Americans want strong border security to go along with a safe system that facilitates a reasonable number of legal immigrants. Most Americans sympathize with the Dreamers and want a path to citizenship for them. Most Americans want to welcome those genuinely fleeing persecution. We Americans know what a great country we have, and we're not stingy or unwelcoming.

But we do want law and order, and we want our elected representatives to, you know, represent us.

## The Left's Favorite Lie: Widespread White-on-Black Violence

Americans are supposed to believe that "blackness is under attack."

This week, a 16-year-old boy named Ralph Yarl — black — accidentally rang the doorbell of an 84-year-old white man, Andrew Lester. According to reports, Lester then shot Yarl twice through the door, wounding him in the head and the arm. According to Clay County prosecutor Zachary Thompson, "I can tell you there was a racial component."

This fact pattern immediately sent the salivary glands of the media and the Biden administration into overdrive. Drooling with excitement, the media headlined the Yarl shooting for days; President Joe Biden himself immediately invited Yarl, who survived, to the White House.

The reason for the journalistic and political feeding frenzy is clear: For the political Left, the narrative of white supremacy must be maintained. What's more, shocking examples of that narrative must be found. Yarl's shooting fit the bill. Americans are supposed to believe, as Yarl's attorney put it, that "blackness is under attack."

This is a lie. Not only is it a lie, it is a blatantly idiotic and devastatingly counterproductive lie. That lie provides the impetus toward undercutting police presence in high-crime areas; it provides the basis for racially discriminatory governmental policies; it provides the foundation for the argument that all disparities between the races are the result of white discrimination.

The truth is far more troubling: In America, while most violent crime is intra-racial (white on white or black on black, for example), in cases in which blacks and whites have violent interaction, blacks are overwhelmingly the perpetrators, not the victims.

In 2019, for example, 3,299 white Americans were murdered; 566, or 17%, were killed by black perpetrators. That same year, 2,906 black Americans were murdered; 246, or 8%, were killed by white perpetrators. Adjusted for population size — there are far more whites in America (235 million) than blacks (47 million) — this means that approximately one out of every million white Americans killed a black person in 2019, while 12 out of every million black Americans killed a white person. Such numbers are reflective of a norm: every year from 2001 on, the number of black-on-white killings has approximately doubled the number of white-on-black killings. When it comes to violent crime generally, the same sad truth applies. In 2019, there were 562,550 reported violent black/white incidents. 472,570 were black on white — 84%.

The media routinely ignore these facts, since they don't fit the narrative. In fact, the media have a general tendency not to even mention the race of perpetrators of crimes if those perpetrators are black. The people harmed most by this narrative failure are not white Americans, but black Americans, who are predominantly the victims of black crime. According to the Department of Justice, "In 2018, based on data from the FBI's Uniform Crime Reporting (UCR) Program, black people were overrepresented among persons arrested for nonfatal violent crimes (33%) and for serious nonfatal violent crimes (36%) relative to their representation in the U.S. population (13%)." The vast majority of victims were black.

Understanding the facts about interracial crime presents different solutions than the lies we hear about the prevalence of white-on-black violence. Those solutions include encouraging fatherhood in the home. Only 37% of black children are living in a home with their biological parents; 72% of black fathers aren't married to the mother of their children; and only 4.2% of black children grow up in areas with a poverty rate below 10% and over half of black fathers present in the community.

But such discussions never take place if we focus on a lie: the lie that black victims are disproportionately the victim of white evils. Those who promulgate that lie victimize all Americans, black and white.

**A message from our State Senator, Donna Campbell**

May 9, 2023

There are three weeks to go in the 88th Texas Legislative Session, and I am blessed to be very busy working toward making Texas even better and stronger!

Last session, every single Texas Senator voted for a bill I filed which changed sex ed from opt-out to opt-in without an expiration date. Then it was tacked on as an amendment to HB 1525, which all senators supported, but an expiration date had been added in the House.

That's why I filed SB 163, to remove that provision because parental rights and responsibilities don't have an expiration date. I am very pleased my bill has passed the Senate and will be heard in the House soon.

The Senate also passed my bill, SB 1567, this week. It will expand access to a variety of instructional mediums by requiring school districts to provide one physical textbook per class room, a teacher instructional textbook (if one exists), and to hold textbooks in the library that equal 5% of the student population per grade for each subject in the library for student checkout.

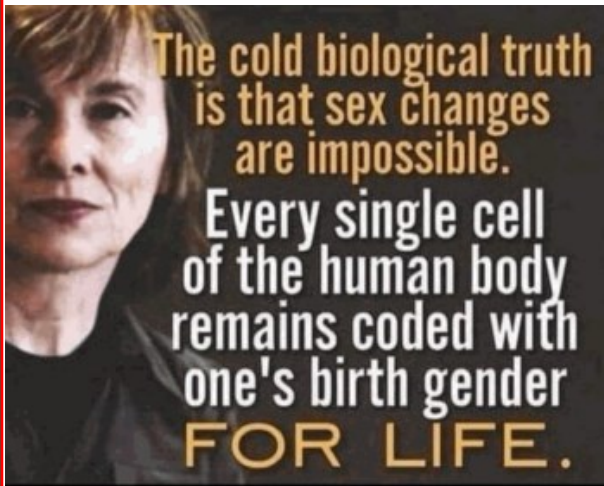
The reason this bill is necessary is simple: there are differences in how people process and retain information when reading from a physical book versus an electronic device, and this bill ensures physical textbooks remain available for Texas students.

The Senate has also passed my Small Business Protection Act, SB 130, which codifies the Third Court of Appeals' decision that local paid leave ordinances are unconstitutional because they violate the Texas Minimum Wage Act. My bill creates a statewide regulatory standard for businesses in Texas.

I am pleased and honored that SB 130 was recognized in recent editorial by Katie Harvey, board chair of the San Antonio Chamber of Commerce, in the San Antonio Express-News: "Senate Bill 130... strikes the right balance by narrowly focusing on employment benefit ordinances and codifying the Third Court of Appeals' ruling (in response to an Austin ordinance) that local paid leave ordinances are unconstitutional because they violate the Texas Minimum Wage Act."

Finally, this past weekend was a painful and tragic one for Texas with horrific situations unfolding in both Allen and Brownsville. Our nation is at a crossroads of good vs. evil, and, with God's help, I believe goodness and mercy will prevail. Please join me in prayer for the victims, their families, and our brave first responders.

I have worked hard to pass these strong, conservative reforms in the Texas Senate. We still have work to do over the next three weeks to ensure Texas remains strong - because there is not another Texas to move to!
