Our Mission

The mission of the Republican Club of Comal County is to promote "Faith, Family, and Freedom" by providing information and education about critical political issues, by encouraging active participation in the political process, by supporting conservative Republican nominees, and by fostering loyalty to the Republican Party and its conservative ideals.

The Republican Contract with America, 2022

1) A Safe and Law-Abiding America. Crime prevention and punishment is mostly a local and state affair. But the federal government promises to prosecute fully any criminal who crosses state lines or uses interstate communications to commit arson, public destruction, smash-and-grab looting, or general attacks on any federal property within the states.

2) Affordable Energy for an Energy-Independent America. Restoration of gas and oil energy independence; reopening of federal lands for new energy leases; fast-tracking natural gas and oil pipelines; encouragement and incentives to mine rare and precious metals inside

the United States needed for batteries and new sources of energy.

3) A Secure Border. Immediate completion of the border wall. Deportation of all those who crossed illegally between 2017 and 2024 and all criminals convicted of felonies or serious misdemeanors; employer sanctions; an end to catch-and-release; all refugee seekers apply outside the United States; a tax on remittances sent south of the border on those here illegally and on public assistance; the end of the primacy of family considerations in fast-tracking immigration requests, replaced by meritocratic considerations of English facility, skill sets, and education. All immigration would be predicated on legality, diversity, meritocracy, and measured and manageable numbers necessary for assimilation and integration.

4) A Sacrosanct Constitution and Preservation of Long-Held Traditions. On record for no changes to the Constitution; no dismantling of the Electoral College; no federalization of states' voting laws; no increase in a nine-justice Supreme Court; no statehood for

Washington, DC, and Puerto Rico; no end to the Senate filibuster.

5) The Restoration of Election Day. Encouragement to the states to limit mail-in balloting, return to the old notion of absentee balloting as an exception rather than the norm, and cut back on extended/early balloting — with the goal that 60 to 70% of ballots cast are done so on Election Day.

- 6) A "Don't Tread on Me" Foreign Policy. Strong support for the sanctity of allied nations. Deterrence against Russia, China, Iran, North Korea, and other belligerents. A realistic foreign policy of "No better friend, no worse enemy." An end to optional large, on-the-ground military engagements in the Middle East. A return of Pentagon emphasis on battle readiness rather than social justice and woke agendas, with budgets redirected to missile defense and naval and air deterrence.
- 7) Towards a Balanced Budget. Expenditures must match revenues. An update of the Simpson-Bowles National Commission on Fiscal Responsibility and Reform or enactment of its recommendations, with the aim of achieving a balanced budget in four years.

8) Anti-Trust, Anti-Monopoly Legislation. An end to Silicon Valley's vast monopolies, cartels, and immunity from public-utility regulations.

- 9) Strict Enforcement of the Civil Rights Act of 1964. Prohibition of the use of racial bias/ advantage/preference in the operations of public local, state, and federal agencies. No federal funds allotted for critical-race-theory indoctrination.
- 10)No Federal Funds for Lawbreakers. An end to federal support of state agencies and private institutions that violate federal statutes and the Bill of Rights, whether sanctuary-city jurisdictions or campuses whose speech and trial codes violate the First, Fourth, Fifth, and Sixth Amendments. Loss of tax-free status on income from university endowments of more than \$10 billion.

Here's What Trump Has Promised If He Wins in 2024

Former president Donald Trump said Wednesday that he's eyeing a "most spectacular" 250th birthday celebration of the United States if he is elected, coming days after he promised to end birthright citizenship for children of illegal immigrants. But the former president, a leading GOP candidate, has made a range of other new policy proposals.

U.S. Celebration

"Three years from now, the United States will celebrate the biggest and most important milestone in our country's history—250 years of American independence," Trump wrote on Truth Social. "That's why as a nation we should be preparing for the most spectacular birthday party. We want to make it the best of all time."

And Trump's campaign said in a news release that the former commander-in-chief will hold a White House task force known as the "Salute to America 250" to hold anniversary celebrations across the United States between Memorial Day 2025 and July 4, 2026.

"I will work with all 50 governors, Republican and Democrat alike, to create the Great American State Fair, a unique one-year exhibition featuring pavilions from all 50 states," he said in a video, proposing a "legendary," special "one-time festival" in Iowa.

"And finally, and most importantly, I will ask America's great religious communities to pray for our nation and our people as we prepare for this momentous occasion," Trump also remarked. "America has been a country sustained and strengthened by prayer and by our communities of faith as we chart a course toward the next 250 years. Let us come together and rededicate ourselves as one nation under God."

Other initiatives include the Patriot Games, an Olympic-style event for high school athletes, and the reissuance of an executive order to restore the Trump-era National Garden of American Heroes that was ultimately blocked by President Joe Biden. That park would have honored great Americans and historical figures, Trump has said.

The timing of Trump's statement is no coincidence. The former president is traveling to Iowa for a tour of the state, which is important launching point during the 2024 Republican Party primary.

"Together we will build it, and they will come," Trump said of the proposed Iowa Fairgrounds event, using a quote from the movie Field of Dreams, which was filmed in Iowa.

100 New U.S. Attorneys

Wednesday's proposal from Trump builds on the patriotic themes that he used during his 2016 campaign and administration. Trump in 2020 established the 1776 Commission dedicated to patriotic education and history lessons, countering the New York Times's "1619 Project" that attempts to reframe the founding of America around slavery.

Months before that, Trump also vowed in a campaign video to fight against who he described as "Marxist" left-wing district attorneys and "overhaul" the Department of Justice in the wake of Manhattan district attorney Alvin Bragg's indictment of Trump for allegedly falsifying business records. If elected, his administration would also appoint 100 U.S. attorneys who are the "polar opposite" of district attorneys who received campaign cash from controversial left-wing billionaire George Soros.

"As we completely overhaul the federal Department of Justice and FBI, we will also launch sweeping civil rights investigations into Marxist local district attorneys," Trump said in a video posted to his YouTube page, which was restored earlier this year after a two-year suspension. "And that's what we have—they are Marxist in many cases."

End Birthright Citizenship

This week, Trump also again vowed to issue an executive order to end birthright citizenship for children born to illegal immigrant parents. Several years ago, Trump signaled that he would issue the executive order, but some legal analysts have said that it would likely face significant legal challenges as birthright citizenship is essentially protected under the U.S. Constitution's Fourteenth Amendment.

Trump's website says /hat he "will again end catch-and-release, restore Remain in Mexico, and eliminate asylum fraud," while "in cooperative states, President Trump will deputize the National Guard and local law enforcement to assist with rapidly removing illegal alien gang members and criminals. He will also deliver a merit-based immigration system that protects American labor and promotes American values."

Death Penalty for Drug Offenders

During his post-midterm announcement for president, Trump also proposed handing down the death penalty for some drug dealers and traffickers, arguing that such individuals are causing death and destruction

"We're going to be asking everyone who sells drugs, gets caught selling drugs, to receive the death penalty for their heinous acts," Trump said at the time. "Because it's the only way."

Critical Race Theory

Trump in January also pledged to cut federal funding to schools that teach the controversial critical race theory along with curriculum around gender identity. While speaking in Davenport, Iowa, Trump promised to keep male transgender athletes out of girls' sports and "bring back parental rights into our schools."

A policy plan also calls for opening new "civil rights investigations into any school district that has

engaged in race-based discrimination."

"As the saying goes, personnel is policy, and at the end of the day if we have pink-haired communists teaching our kids we have a major problem," Trump said earlier this year. "We're at the end of the list on the tens in advention no matter where you go education, and yet we spend the most, but we're going to be tops in education no matter where you go anywhere in the world."

Jan. 6 Pardons

More than two years after the Capitol breach on Jan. 6, 2021, Trump said last month that he would pardon a range of individuals who were convicted and sentenced in connection to the incident. Those pardons, he said, will "be very early on" in his presidency.

"I am inclined to pardon many of them," Trump said at a town hall hosted by CNN last month. "I can't say for every single one, because a couple of them, probably they got out of control."

Similarly, Trump's chief rival, Florida governor Ron DeSantis also promised he would also pardon individuals who were convicted in connection to the Jan. 6 Capitol breach. DeSantis made his presidential ambitions public during an announcement late last month.

Stop and Frisk

And Trump has also promised to have police departments around the United States implement the "stopand-frisk" policy to detain and search civilians for contraband items and weapons. For years, New York City police departments used the police tactic, which has been described by a number of enforcement groups as an effective policy. A federal judge in 2013 deemed the policy unconstitutional.

Freedom Cities

In possibly his most far-reaching proposal, Trump said he wanted to create a plan to come up with "freedom cities" on federal land and wanted to hold a contest to design 10 new cities built around "hives of

industry." He said the initiative would be a "quantum leap in the American standard of living."

"President Trump has a lot of unfinished business," Jason Miller, a senior campaign adviser, told NBC earlier this year about Trump's vision of the future. "He has a very clear vision for what he wants to do for a second term."

Energy Dominance

Trump also said he would also "unleash the production of domestic energy resources, reduce the soaring price of gasoline, diesel and natura gas, promote energy security for our friends around the world, eliminate the socialist Green New Deal, and ensure the United States is never again at the mercy of a foreign supplier of energy."

Crime

"There is no higher priority than quickly restoring law and order and public safety in America," said his campaign website, adding that he will make a priority to "revitalize police departments and reclaim safety, dignity, and peace for law-abiding Americans. He will deliver record funding to hire and retrain police officers, strengthen qualified immunity and other protections for police officers, increase penalties for assaults on law enforcement, put violent offenders and career criminals behind bars, and surge federal prosecutors and the National Guard into high-crime communities."

Race Heating Up

Trump has also increased his criticism of Governor Ron DeSantis after the he officially announced his 2024 presidential bid last week, noting that some polls show DeSantis is trailing Trump by more than 30 percentage points. And this week, the former president highlighted a survey that shows Trump ahead of DeSantis by about 42 percentage points.

Arguing that DeSantis lacks charisma, Trump has sought to cast DeSantis as disloyal after he endorsed him during his 2018 gubernatorial bid. DeSantis has started to push back against Trump's claims, saying that the former president has too much baggage to win in 2024.

And polls have consistently shown that DeSantis is ahead of other Republican presidential candidates, including former U.N. ambassador and governor of South Carolina Nikki Haley, Sen. Tim Scott (R-S.C.), businessman Vivek Ramaswamy, radio host Larry Elder, and former Arkansas governor Asa Hutchinson.

Former vice president Mike Pence is reportedly also slated to announced his presidential bid in the coming days, while reports have indicated that former New Jersey governor Chris Christie, who had endorsed Trump and headed his transition planning team in 2016, will make an announcement on a possible 2024 run soon.

In the midst of the Trump criticism, DeSantis has appeared on Fox News multiple times for interviews about various subjects. That has also drawn the ire of Trump, who this week criticized former White House press secretary-turned-Fox host Kayleigh McEnany for focusing on DeSantis's campaign.

'Treated Like A Criminal': Prof Alleges College Axed His Contract, Banned Him From Campus Over Conservative Beliefs

A professor told the Daily Caller News Foundation that he was fired and banned from a small college in Texas because of complaints from students and colleagues regarding his conservative beliefs.

St. Philip's College (SPC), located in San Antonio, Texas, as part of the Alamo College District, declined to renew political science professor Will Moravits' contract on March 27 after a Title IX investigation was launched in February regarding a student complaint that he made disparaging comments about the LGBTQ community during class, according to a documents obtained by the DCNF. Moravits, who was scheduled to teach courses through the 2024 spring semester but has since been banned from campus, denied that he made any such comments, instead alleging that his termination was due to facilitating lectures on topics that the student found offensive.

"They made it very clear early on that I was not going to be reinstated under any circumstances," Moravits told the DCNF. "That was not an option."

'I Know Them To Be False'

A student alleged that Moravits made multiple statements during an Introduction to Political Sciences class including that the "LGBTQIA+ community is riddled with pedophilia," "the 'p' in LGBTQIA+ stands for pedophilia" and that "gay pride activists organize parades with 12-year-olds jerking off in them," according to the notice of complaint sent to Moravits on Feb. 13 and provided to the DCNF. The complainant also alleged that Moravits, who is a former police officer, argued that police brutality is needed and that he "instigates discussion between students, especially those who agree with him" during classroom discussions on controversial topics that are "irrelevant to the class."

Moravits was notified of his suspension on Feb. 9 before being fully informed of the complaint against him on Feb. 13, according to the obtained documents. He was not permitted on campus nor to have contact with individuals, including students, during the investigation, which he was informed on April 21 was closed — nearly a month after the school decided not to renew his contract on March 27.

Moravits, however, denies he made the alleged comments.

"The student's frivolous complaint and Alamo's punitive actions in response to it clearly targeted Dr. Moravits' protected speech as a teacher in the classroom," a legal letter sent to the college by attorney Michael Allen and obtained by the DCNF reads. "The student complaint arose in POSI 2304, Introduction to Political Science. In that class, Dr. Moravits did nothing more than ask students to engage all sides of controversial issues, such as police brutality and gender ideology. Many of his engagements with students in class discussion came in direct response to their questions."

Moreover, three students in the course signed affidavits, obtained by the DCNF, that state they did not hear Moravits make the alleged statements. Moravits has also received several "excellent" teaching evaluations and received good reviews from students, according to the legal letter.

"I believe that if such unusual thing were said in GOVT 2304 that they would stand out in my mind, and I would have remembered them," one student, who was also interviewed during the investigation, wrote. "If these things were said about Dr. Moravits, I do not know why any student would make these accusations, and if such accusations were made, I know them to be false as a direct participant in the class."

Another student, who said they were African-American, confirmed in the affidavit that they "never felt uncomfortable," "demeaned" or "offended" in the class, nor does the student recall other classmates being "uncomfortable."

"Dr. Moravits always went out of his way to discuss with the class how different people viewed controversial issues, so that the class heard all sides of an issue. He then left it up to us to make up our own minds. Dr. Moravits himself would not take sides, and he would correct students if they misunderstood him. In my experience of class, which I thought was a very good class, Dr. Moravits was always fair and respectful to all students and showed respect for students' ideas and opinions," the student wrote. "This is exactly what I went to school for, to learn about these kinds of things."

The third affidavit was not immediately provided to the DCNF.

No Determination Of Responsibility

Nevertheless, Moravits was informed on March 27 that his contract would not be renewed. The notice, obtained by the DCNF, did not list a specific reason for the decision but confirmed that his current contract as an Instructor and his paid administrative leave would end on May 13.

"You will remain on administrative leave and paid through May 13, 2023, which is the end date of your contract," the notice reads. "While you are on administrative leave in April and through May 13, 2023, you are expected to be available by telephone or virtually (Zoom) during regular business hours in the event that work-related matters need to be discussed."

Moravits was also not permitted on campus and ordered to have no contact with individuals, including students, according to the notice of suspension sent to him on Feb. 9 and shared with the DCNF. He attempted to retrieve his belongings from his office on May 17 but was escorted from campus by four police officers, according to an email outlining the incident he sent to the HR department, obtained by the DCNF.

"I was treated like a criminal," he told the DCNF.

Moravits was notified on April 21 that the investigation was dropped "without any determination of responsibility" because of a written appeal he provided and because the case was considered closed, according to an email shared with the DCNF. Allen said that while at-will employees can be terminated without cause, the college cannot "violate their constitutional rights."

"We think the timing and the fact that they immediately threw him off campus on the basis of false allegations that he had hurt someone's feelings ... obviously they weren't getting what they wanted out of the investigation and wanted to fire him," Allen told the DCNF. "They wanted to fire him from the get-go."

'Racist Organization'

Moravits believes that he was "terminated," per the legal letter, because of his conservative beliefs. He provided two screenshots to the DCNF of text messages from Cynthia Pryor, SPC Social and Behavioral Sciences chairperson, to another SPC employee about him promoting his book, "The Blue Divide: Policing and Race in America", at the Conservative Political Action Conference (CPAC) in 2022.

"Well, I was stunned to see that Moravits hawked his book at the CPAC convention. CPAC has become a racist organization that promotes 'racial purity' and supports authoritarians such as Viktor Orban in Hungary," Pryor allegedly wrote. "Moravits seems to be associating with an anti-democratic group. That was surprising to me. He hid that part of his political philosophy quite well until he got the job."

She then sent a second text sharing that she hoped the school could "push Moravits out."

"I'm not opposed to open dialogue about competing ideas, but he was somewhat dishonest, and the views of CPAC threaten our democracy," the text reads. "He needs to be vigorously challenged."

The legal letter used the texts to showcase a "culmination of a long history of targeted attacks" on Moravits. The letter also referenced a complaint filed by colleagues regarding an interview he gave about his book which was done in his own capacity.

Moravits has lost approximately \$24,000 due to the non-renewal, he told the DCNF. The school has declined to reinstate him to his position with full benefits and lost revenue as was requested in the April letter, meaning he will consider filing a lawsuit.

"What institution fires an employee who's valued by the students? Basically it's the HR department claiming that the students are customers in the academic industry at the moment and that they should be able to assert the right not to have their subjective feelings hurt, and yet they don't care about the students who were valuing that education experience that was provided by Dr. Moravits," Allen told the DCNF. "So what institution does that? They have affirmative evidence that this was a false allegation."

St. Philip's College did not respond to the DCNF's request for comment. Pryor could not immediately be reached for comment.

Legislature Passes My Bill to End Child Gender Modification!

I am excited to report that my bill, SB 14, has passed the Legislature and is headed to Governor Abbott's desk to be signed into law. This bill puts an end to harmful, unnecessary gender modification procedures on children in Texas.

This bill is the compassionate solution to protect vulnerable children. As a medical doctor, I am pleased that the Legislature has recognized the reality of the science of adolescent care and stepped in to protect young Texans!

As I mentioned last week, during the last session, every single Texas Senator voted for a bill I filed which changed sex ed from opt-out to opt-in without an expiration date. Then it was tacked on as an amendment to HB 1525, which all senators supported, but an expiration date had been added in the House.


That's why I filed SB 163, to remove that provision because parental rights and responsibilities don't have an expiration date. I am very pleased my bill has passed the Senate and has been approved in House committee. I am pushing hard to get a House vote on this bill in the waning days of the session.

SB 2527 seeks to strengthen current telemedicine laws. While we want to encourage the use of telemedicine as a convenient, cost-effective means to provide care, the lack of initial in-person visits has lead to abuse in the prescribing of certain scheduled drugs. This bill will also protect those using telemedicine services by creating a private right of action for anyone wrongfully harmed by the fraudulent practices of some companies.

The bill will also put a stop to bad actors who are requiring doctors to prescribe specific controlled substances, establishing quotas of prescriptions that must be filled, or allowing patients to select a medication before being examined.

SB 2527 has also passed the Senate and has been reported out of the House Public Health Committee. This is another bill I will work to pass through the House in the coming days.

I have worked hard to pass these strong, conservative reforms in the Texas Senate. We still have work to do over the next few days to ensure Texas remains strong - because there is not another Texas to move to!




