Our guest speaker for July: Chris Byrd

J. Christopher Byrd is a member of the State Republican Executive Committee. He appointed as the Vice Chair for the Resolutions Committee and well as a member of the Legislative Priorities Committee. Additionally he has been chosen to serve as the Chair for the SREC Legislative Priorities Sub-Committee on Gun Rights.

In His Own Words:

"I believe people do what is important to them. Currently, I am spending a great deal of time on two initiatives with Col. Phil Waldron, (Ret.), one being a private sector response to the evil slave/sex trade here in Texas and the other concerning election integrity, both also involve Walter West, (Ret.). The RPT has previously budgeted funds for an ongoing Constitution Day project I began a few years ago where we coordinate lawyers and judges to present to thousands of high school students lessons on the Constitution and give out pocket Constitutions. I am an active precinct chair in Comal County (6 years) and an elected delegate for the last three state conventions as well as a National Convention Delegate, alternate (nominated by Mark Dorazio) in 2020.

As a Sophomore at Amarillo High, I challenged the AISD over discrimination against female student athletes, with what later won the Best Editorial of the Year, which forced the AISD to revise their budget and implement equality for female sports. While in law school, Texas Tech published my dissertation on "The Right to Anonymity" and requested the Texas legislators to amend Texas Penal Code 38.02 making it constitutional, which occurred.

I served as the lead attorney stakeholder in passed legislation to preserve American Laws in American Courts (ALAC) in Texas (HB45) and preventing foreign laws from being honored in Texas courts if such violates fundamental constitutional rights. This was chiefly made necessary by Sharia being honored in Texas courts.

I have also served as counsel for Truth In Texas Textbooks Coalition and co-founded an ongoing program known as EarlyAct FirstKnight (EAFK), a multi-state program providing school curriculums for students to learn why and how to serve, partnering with local Rotary Clubs. While my children were in grade school, I co-founded, a classical/principle approach K-12 school which ran successfully for 20 years in Oklahoma. After moving to Spring Branch with my two children, I homeschooled my daughter through graduation.

In addition to being a citizen activist on legislation initiatives, I assisted in the passage of the Pastor Protection Act and have worked on bill drafting and testifying in both chambers on numerous proposed bills.

I enjoy speaking on the American Covenant, Sharpening the Sword, the Constitution, Sharia, 7 Days in Nineveh (where I traveled to three years ago to meet the Christian remnant) and have been honored to do so across Texas in over 75 speaking engagements."

Our Mission

The mission of the Republican Club of Comal County is to promote “Faith, Family, and Freedom” by providing information and education about critical political issues, by encouraging active participation in the political process, by supporting conservative Republican nominees, and by fostering loyalty to the Republican Party and its conservative ideals.

The Republican Contract with America, 2022

- 1) A Safe and Law-Abiding America. Crime prevention and punishment is mostly a local and state affair. But the federal government promises to prosecute fully any criminal who crosses state lines or uses interstate communications to commit arson, public destruction, smash-and-grab looting, or general attacks on any federal property within the states.
- 2) Affordable Energy for an Energy-Independent America. Restoration of gas and oil energy independence; reopening of federal lands for new energy leases; fast-tracking natural gas and oil pipelines; encouragement and incentives to mine rare and precious metals inside the United States needed for batteries and new sources of energy.
- 3) A Secure Border. Immediate completion of the border wall. Deportation of all those who crossed illegally between 2017 and 2024 and all criminals convicted of felonies or serious misdemeanors; employer sanctions; an end to catch-and-release; all refugee seekers apply outside the United States; a tax on remittances sent south of the border on those here illegally and on public assistance; the end of the primacy of family considerations in fast-tracking immigration requests, replaced by meritocratic considerations of English facility, skill sets, and education. All immigration would be predicated on legality, diversity, meritocracy, and measured and manageable numbers necessary for assimilation and integration.
- 4) A Sacrosanct Constitution and Preservation of Long-Held Traditions. On record for no changes to the Constitution; no dismantling of the Electoral College; no federalization of states' voting laws; no increase in a nine-justice Supreme Court; no statehood for Washington, DC, and Puerto Rico; no end to the Senate filibuster.
- 5) The Restoration of Election Day. Encouragement to the states to limit mail-in balloting, return to the old notion of absentee balloting as an exception rather than the norm, and cut back on extended/early balloting — with the goal that 60 to 70% of ballots cast are done so on Election Day.
- 6) A "Don't Tread on Me" Foreign Policy. Strong support for the sanctity of allied nations. Deterrence against Russia, China, Iran, North Korea, and other belligerents. A realistic foreign policy of "No better friend, no worse enemy." An end to optional large, on-the-ground military engagements in the Middle East. A return of Pentagon emphasis on battle readiness rather than social justice and woke agendas, with budgets redirected to missile defense and naval and air deterrence.
- 7) Towards a Balanced Budget. Expenditures must match revenues. An update of the Simpson-Bowles National Commission on Fiscal Responsibility and Reform or enactment of its recommendations, with the aim of achieving a balanced budget in four years.
- 8) Anti-Trust, Anti-Monopoly Legislation. An end to Silicon Valley's vast monopolies, cartels, and immunity from public-utility regulations.
- 9) Strict Enforcement of the Civil Rights Act of 1964. Prohibition of the use of racial bias/advantage/preference in the operations of public local, state, and federal agencies. No federal funds allotted for critical-race-theory indoctrination.
- 10) No Federal Funds for Lawbreakers. An end to federal support of state agencies and private institutions that violate federal statutes and the Bill of Rights, whether sanctuary-city jurisdictions or campuses whose speech and trial codes violate the First, Fourth, Fifth, and Sixth Amendments. Loss of tax-free status on income from university endowments of more than \$10 billion.

Rep Isaac Statement on Paxton Impeachment

My duty to defend our Constitution and uphold the rule of law is the constant guide to my actions as an elected representative of this state. After reviewing testimony and the transcript shared with me by the General Investigating Committee regarding the Office of the Attorney General, I am concerned about the allegations. However, I am also gravely concerned with the following substantiated facts:

- The FBI, U.S. Department of Justice, and a federal grand jury have been investigating the whistleblower allegations since at least December 2020. Since then, the Biden Administration has weaponized the Department of Justice under Merrick Garland and demonstrated a willingness to target political enemies. In light of Attorney General Paxton's successful litigation against the federal government that has stymied the agenda of the Biden Administration, it is certain that Paxton is at the top of the list as a Biden political target. If there was evidence to support the whistleblower allegations, Paxton would have been indicted and arrested by now.
- The General Investigating committee stated in its May 26, 2023, memorandum to the House that **"but for Paxton's own request for a taxpayer-funded settlement over his wrongful conduct, Paxton would not be facing impeachment by the House."** This concedes that the other allegations in the articles are insufficient by themselves for impeachment.
- The articles of impeachment are invalid and violate Texas law because they allege acts that occurred prior to November 2022, when Attorney General Paxton was last elected, in violation of Tex. Gov't Code 665.081. The impeachment powers under Tex. Const. Art. XV do not trump 665.081, because the legislature has voluntarily limited the scope of impeachment through the enactment of this statute.

Additionally, I do not believe that some members of the House, myself included, have a good understanding of the adequacy, legality, or fairness of the impeachment process. We are being asked to vote on impeachment while in the midst of considering the House budget, and many other legislative items of great importance. I cannot vote to impeach when the members of the full House have had no direct access to witnesses or supporting documents, and have had no time to properly prepare and understand the matters in question. The simple truth is that the evidentiary basis to impeach Attorney General Paxton has not been properly established.

The process in handling the Articles of Impeachment must be above reproach so that we may confidently execute our duty, fully absorb, and act upon the relevant information. Because of these concerns and the facts listed above, I cannot in good faith vote in favor of impeachment.



Texas is winning the war against 'woke'

Through the regular Texas legislative session, noisy protesters filled the Texas Capitol to testify in support of a range of "woke" issues: the diversity, equity and inclusion ideology of systemic racism, nonbinary genders, biological males competing with females in women's and girls' sports, drag shows for children, and even defunding the police. Some challenged the legislators fighting "wokeness," insisting that "woke" is merely a left-wing term meaning "stay aware."

Even the left-leaning Associated Press Stylebook has accepted that "woke" is conservative shorthand for every crazy idea the left is pushing.

Texas lawmakers attacked those crazy "woke" ideas starting at their power center — college campuses — by passing the strongest anti-DEI bill in the nation. Texas closed DEI offices on every state campus, and prohibited mandatory DEI training and DEI statements to be hired. They also reined in Democratic-led cities with the "Death Star" bill that will prohibit city leaders from overriding state law. They blocked male athletes from competing with female ones on college campuses and prohibited children from being exposed to drag shows. Children will also be protected from cross-sex hormones, puberty blockers and sex-change surgeries before they are 18.

A new Gallup Poll makes it clear that the Texas anti-"woke" agenda is much bigger than Texas. Most Americans agree with Texans on these issues. The number of people who call themselves social conservatives has increased 8 points in just two years while the number of people who call themselves socially liberal is dropping.

To just look at one issue, support for "trans rights," which affect those suffering from gender confusion, is falling. According to Gallup, the number of Americans who oppose transgender men playing in women's sports has increased to almost 70%, about the same as the percentage of Texans who oppose it. Predictions by the left that "trans rights" would gradually evolve into broader acceptance, as gay rights have, seem to be off base.

The Washington Post reluctantly reports in its own poll that almost 60% of Americans "don't believe it is even possible" to be any sex other than the sex you were at birth. Similarly, the Texas Polling Project also found that 63% of Texans believe that sex is determined by what is on your birth certificate.

Population data regarding "trans" people are suspect, but even with all the hype, The Washington Post says only about 0.6% of the population calls themselves "trans." If you add in those who believe they are somehow "nonbinary" (some gender other than male or female), that figure increases to 1.6%. According to The Washington Post, 2.4% of the population is gay — although the number is much higher among younger people. As Bill Maher has hilariously pointed out, the number of young people who now say they are gay is escalating so rapidly that the entire population will be gay by 2054.

Interestingly, a Summit poll found that about 69% of Americans attribute the skyrocketing numbers of young people who suddenly believe they are the opposite sex to cultural infusion through the media as well as the influence of the health care industry, which produces puberty blockers and sex transition surgical centers. Regardless of the cause, the majority of Americans support Texas' legislation that restricts discussions of gender identity and adult sexuality in elementary school classrooms.

Disagreement regarding so-called trans issues isn't the total reason for the substantial shift toward social conservatism among Americans. Progressives pushing ideas that all American and Texas history is a lie, that White supremacy is ubiquitous, and that racism is in America's DNA are also chief causes. So is defunding the police, even as our cities are being destroyed by crime.

Ignoring predictable progressive charges of racism and transphobia, Texas lawmakers took on the "woke" insanity, and they won. They took significant steps to return reason and free speech to our college campuses, protect our children and women's sports, and help restore safety and vitality to our cities. The numbers in the latest Gallup Poll showing an increase in social conservatism make it clear that Americans across the country would like to see more of the same in their states.

This Pride Month: America Pushes Back

Catholic Vote, June 19, 2023

During this year's "Pride Month," Americans are pushing back against the LGBTQ movement in a groundswell of parental activism such as CatholicVote's "Hide the Pride" Campaign.

CatholicVote describes Hide the Pride as "a parent-led movement to empty local taxpayer-funded libraries of progressive sex- and gender-related content aimed at children."

Parents across the U.S. have emptied their local libraries' "Pride" displays this month, often replacing the "Pride" books with wholesome ones.

"This year's campaign proved that parents would not stand idly by while LGBTQ operatives exposed children to explicit material in taxpayer-funded libraries," said CatholicVote Associate Editor Erika Ahern. "Even liberal news sites admitted CatholicVote's campaign has been 'extremely successful.'"

The parents participating in Hide the Pride are not alone. More and more parents, teachers, and concerned citizens are speaking openly against the LGBTQ movement's increasing focus on minors.

According to the latest Gallup polling data, Americans today are less supportive than they were two years ago of the LGBTQ agenda.

"A majority, 55%, consider 'changing one's gender' to be more 'morally wrong,' while 43% say it is 'morally acceptable,'" the poll found. More people now believe 'changing one's gender' is morally wrong, and fewer now believe it is 'morally acceptable. In 2021, 51% of respondents" thought changing one's gender was morally wrong, and 46% morally acceptable."

Another poll found that 65% of Americans believe there are only two genders — an increase of six percentage points in the past two years alone.

Sarah Parshall Perry reported at The Daily Signal that "parents and kids are both flexing their muscles in opposition to schools that are all in on 'Pride.'"

This year, children have protested "Pride" videos in math classes, rainbow-filled school halls, and an 18-year-old boy identifying as "trans" and stripping in a girls' locker room.

"More and more parents are standing up for their rights and defending their children's hearts and minds," said Ahern.

"For once, the alphabet mob is back on its heels," wrote Perry. "But only because taxpaying parents and their brave kids are speaking up."

****SCAMS, SCAMS and more SCAMS****

The Garden Ridge Police Department as well as every other Law Enforcement Agency in the area has been putting information out to the public regarding email and phone scams. I would like to tell everyone again that there are a lot of scams out there being perpetrated on our local communities, so please don't fall victim.

The most common versions of these scams recently are the "relative in jail and needs bail money" or the "you have a warrant and will be arrested" varieties. The bail money scam usually involves someone calling saying they work for a jail or lawyer and you have a relative who has been arrested and they need fine and bail money. They will even go as far as putting someone on the phone to pose as your relative and say they sound different because they were injured and have a broken nose.

The second one, which is very popular right now, is calling and telling you they are either Amazon or some other big business Fraud Unit. Once they have you on the phone, they will transfer you to someone else they claim works for a bank or Law Enforcement and you need to pay a large amount of money in order not to be arrested for money laundering or some other unusual charge. They will try to talk you into going to your bank to withdraw money and even offer advice to you on what to say to the bank teller when they warn you about scams and ask why you are suddenly withdrawing large amounts of money. For example, thieves have told people to tell the bank they are remodeling their house. Once you have the money withdrawn, they will instruct you to either go to a specific location and deposit it into a Bit Coin machine, which also has warnings on it telling people to be aware of scams, or send the cash to them through Fed Ex.

I am putting this out again in hopes of bringing more attention to what is currently happening in our community and asking those of you out there who know of these scams to help those who may not be so informed or our vulnerable population of the elderly. It is happening on a regular basis in our area and are almost impossible to track the thieves due to computer technology.
