will meet on Tuesday, July 23, at 6:30 p.m. (social mixer at 5:30)


at the First Protestant Church of New Braunfels, 172 W. Coll Street. (Enter the parking lot by the Civic Center from Coll St.)

Dr. Robin Armstrong, M.D.

Dr. Robin Armstrong has always worked to be a servant leader throughout his life. He has been married to Martha Armstrong for 24 years and has four sons, Daniel, Gabriel, Joshua, and Noah. Dr. Armstrong was born in Texas City, Texas, and attended La Marque High School, where he graduated in 1987. Dr. Armstrong played football on a state championship runner-up team and ran track and field in high school. He attended Texas A&M University and earned a degree in microbiology in 1991.

Dr. Armstrong returned home after college, attended medical school, and completed residency at

the University of Texas Medical Branch in Galveston.

Dr. Armstrong met his wife Martha in medical school where they were gross anatomy partners. They dated in medical school and were married December 13, 1997. Five and a half years later they gave birth to their son Daniel, and eventually had three more sons.

Dr. Armstrong is a man of deep faith, and his faith directs his values and beliefs. He believes that all men and women have an eternal flaw, are loved by God, and saved by grace. His motivation to serve is moved by this motivation. He has served on two missionary journeys to Africa, has been to Nicaragua on a medical missions, and has been involved in his local church for many years to present.

Dr. Armstrong practices medicine in his home town and is an owner of Armstrong Medical Group, which is a group of hospital and nursing home physicians, nurse practitioners, and physician assistants. Their largest hospital-based practice is at the hospital where Dr. Armstrong was born. He has been involved at all levels of hospital leadership including on the Board of Directors of the

hospital, President of the Medical Staff, Chief of Staff, and Chair of Internal Medicine.

Dr. Armstrong has been involved politically as well, serving locally as a precinct chair while in his medical residency. He has served as an election judge, a city chair, as an executive committee member of the Republican Party of Texas (SREC), and as Vice Chair of the Republican Party of Texas. In June 2012 he was elected to the Republican National Committee (RNC) as Texas' National Committeeman, where he serves today as Vice Chair of the Southern Region of the RNC, Rules Committee member, and on the Faith Advisory Board of the RNC.

Dr. Armstrong also previously served on the Finance Commission of Texas, where he was appointed by Governor Greg Abbott on April 2, 2019. The Finance Commission is the state

regulatory agency for the banking industry and savings and loan industry.

Dr. Armstrong has been a frequent guest on One America News Network and NEWSMAX television. He has been on radio programs all over the United States, including major media markets of Houston, New York City, Las Vegas, and many others. He has appearances on Fox News' Laura Ingraham Show, the Glen Beck Radio Program, and the Ron Paul Podcast show. Dr. Armstrong has been featured in national publications such as Rolling Stone Magazine, the New York Times, the Wall Street Journal, US News and World Report, and USA Today. He was featured for his successful treatment of 38 COVID-19 patients at one of his nursing facilities where he serves as medical director. Dr. Armstrong has been on healthcare panels with President Trump in



attendance at the White House and recently participated with President Trump on a panel named "Transition to Greatness."

Biden inflation law messed with seniors' Medicare coverage. Here's how. By Dr. Robin Armstrong, May, 2024

It's been almost two years since President Joe Biden's so-called Inflation Reduction Act took effect, with the promise of lowering drug costs and increasing access to both prescriptions and coverage. The outcome of this new federal policy has been, not surprisingly, quite different from what was sold to the American people.

The law is yet another example of the Biden administration making unrealistic promises and pretending that Americans will not notice when they have less health coverage, reduced access to prescription drugs and fewer options in the marketplace, all while paying more in premiums. The authors of the inflation law knew that the changes they were making to Medicare would result in higher premiums; they just falsely believed that government controls would prevent consumers from being hit the hardest.

In reality, premiums have increased significantly — by more than 22%, with rates expected to continue to rise. While they do, Plan D options continue to dwindle, with the fewest number of plans available than ever before. In the last year alone more than 100 plans have been removed from the market — a 50% reduction in plans compared to the first year of the program.

Those hardest hit by this Biden policy: low-income Americans who are already living paycheck to paycheck. Low income seniors have far fewer options today than they did this time last year. According to the Kaiser Family Foundation, there has been a 34% reduction in plans offered to those seniors. We are doing a disservice to our most vulnerable by reducing their options for care.

Not only has the Biden inflation law resulted in more out-of-pocket costs to Americans, but the impact of government intervention into the marketplace has also drastically reduced the amount of funding that goes toward research and development for new treatments. While this program was heralded as one of "innovation" and "ingenuity," there is nothing to celebrate when costs go up and options go away. In fact, this is something we should be quite ashamed of. It's a reminder of why every Republican member of Congress voted against the Inflation Reduction Act.

When Congress passed the law in 2022, many promises were made. Time has shown how quickly the administration forgot those promises. It's time we use our voices to push back against government intervention in healthcare and demand that all price discounts negotiated between drug manufacturers and insurance companies actually go to patients.

It's just another reminder that in Joe Biden's America, everything costs more.

Safeguarding Texas Healthcare: Rejecting PBM reform for patient prosperity

In the Lone Star State, where individualism and self-determination are central to our way of life, the looming specter of Pharmacy Benefit Manager (PBM) reform raises concerns among Texans who staunchly oppose socialist government interference and control. As the debate over healthcare policy unfolds in Congress, lawmakers must promote the principles of limited government and personal freedom by avoiding extreme government controls on our private healthcare system. The proposed changes threaten to restrict PBMs' ability to negotiate lower pharmaceutical costs and save patients money and oppose our Texan ethos that champions independence and a free-market approach.

The business practices of PBMs have undergone significant evolution over the past fifty years, yet their <u>fundamental roles</u> remain unchanged. PBMs employ tools that save money, ensure access to life-saving medicines, and prevent fraudulent activities. At the core of their operations are the crucial tasks of developing and maintaining drug formularies, negotiating with pharmacies, wholesalers, and drug manufacturers on behalf of plan sponsors, establishing and overseeing a network of pharmacies, and contributing to the expansion of mail-order pharmacy services. These capabilities and services have, on average, saved patients in Texas and across the country an average of <u>\$1,040 annually</u>, an impressive testament to their effectiveness in reducing drug costs. Protecting the financial security and health of Texas patients and all those across the country should be a top priority. Reforms that disrupt the delicate balance of these negotiations and tools could lead to increased costs for patients and undermine their ability to access essential treatments. Lawmakers must carefully weigh the potential benefits against these risks to ensure the affordability of medicines for the constituents they serve.

There is also the valid concern that the Bernie Sanders-backed provisions targeting PBMs would be a step closer to a socialized healthcare system. Implementing increased bureaucratic measures and red tape would align with Sanders' progressive agenda and could result in significant and widespread consequences, potentially reshaping the fundamental principles of our healthcare system. Pushing back against his progressive policies and the expansion of government-run healthcare is imperative, and we must ensure we are not compromising the free market components of our healthcare infrastructure that are working well.

Moreover, some lawmakers have suggested the inclusion of price caps in the PBM reform efforts. Setting specific prices or regulating rates for PBMs would disrupt the healthcare market and reduce their ability to negotiate effectively. This would ultimately turn power over to government bureaucrats and harm patients. I applaud Sens. Ted Cruz (R -TX and John Cornyn (R-TX) and Rep. Pete Sessions (R-Waco) for their steadfast stance against price caps during deliberations on the Inflation Reduction Act and am hopeful that they will continue advocating against price caps as PBM reform takes center stage in Congress.

Texas federal legislators must oppose PBM reform given the negative repercussions for patients. Preserving a competitive marketplace and the financial security of patients is essential. Let's steer clear of jeopardizing the effective and cost-efficient role that PBMs play in our state's healthcare ecosystem by resisting calls for heightened government interference.

Illegal Alien Crimes and Liberal Silence and Excuses

On Wednesday, June 26, there was a fourth incident in ten days where an American female - or females – were killed by illegal aliens. What is surprising is the silence among liberals, especially liberal women's groups, about this frightening trend that is associated with the Biden open, unsecured border.

Liberal groups justify Biden's border policies as "humanitarian" but ignore the tsunami of criminal illegal aliens, terrorists, and illicit drugs coming into the country. The murders show the danger of allowing unvetted illegal aliens into our communities.

Specifically, the following murders were reported in the news between June 17 and June 27, 2024.

- ♦ Monday, June 17 An illegal alien from El Salvador was arrested in Tulsa, OK, for the rape and murder of Rachel Morin in Harford County, MD, in August 2023. Victor Martinez-Hernandez, 23, was tracked down by police using DNA from the crime scene in Maryland. He had also assaulted a woman in Los Angeles and murdered another one in El Salvador.
- ♦ Tuesday, June 18 Jhon Moises Chacaguasay-Ilbis, a 21-year-old illegal alien from Ecuador, was arrested by Syracuse, NY, police for allegedly suffocating a woman and burying her body in a city park.
- ♦ Thursday, June 20 Two undocumented Venezuelan men have been charged with the capital murder of 12-year-old Jocelyn Nungaray in Houston, TX. They might also be accused of rape.
- ♦ Thursday, June 27 Irving, TX, police arrested Oved Bernardo Mendoza Argueta, 37, for the double homicide of two women inside a Chick-fil-A restaurant. The two female victims, 49-year-old Patricia Portillo and 31-year-old Brayan Alexis Godoy, were employees of the restaurant.

Besides these recent incidents, there have been several other high-profile murders of American women, such as Mollie Tibbetts in Iowa, Kate Steinle in San Francisco, Laken Riley in Georgia, and Catalina Valdez Andrade and Merced Andrade Ballon in Farmers Branch, Texas. There have also been other attacks on women and young girls in small communities that do not get national news attention.

A secured border and a stringent vetting process could have prevented these crimes. Immigrants and foreign aliens should only enter the U.S. with a proper background check and permission.

However, in many cases, it is impossible to do background checks because records of crimes and criminals do not exist in many countries. This lack of information makes it easy for illegal aliens to use fake names to enter the U.S. Also, there is a substantial number of illegal aliens crossing daily, many undetected, which makes identifying criminals more difficult.

It is the Biden Administration's liberal and lax immigration policies and unsecured borders that are responsible for illegal alien criminals being in America. Under Biden's Homeland Security Secretary Alejandro Mayorkas, aliens are allowed into the country first and then apply for permission to stay.

This backward and hurried processing makes it challenging to identify criminals and terrorists when they cross the border. They can melt into the communities until they commit a crime.

However, liberal political issues like the unsecured and open border are more important than women's safety. For example, Harris County (Houston), TX, County Judge Lina Hidalgo, a liberal Democrat, said "evil happens regardless of immigration status" and urged fellow leaders not to politicize the 12-year-old's alleged murder at the hands of two undocumented Venezuelan men. Secretary Mayorkas said illegal alien criminals should be blamed for the murder, not the Biden Administration.

The Brennan Center for Justice, a liberal think tank, released a report in May 2024 that concluded, "Data does not support claims that the United States is experiencing a surge in crime caused by immigrants." Does this mean that illegal alien crime and violence are tolerable to liberals and Democrats?

Regardless of the liberal excuses, these murders were preventable because the illegal alien criminals should not be in the U.S. Some countries of the world that have taken advantage of the lax Biden border policies and dumped their criminals and mentally ill citizens in the U.S.

The Border Patrol must be allowed to do their duty to secure the border and prevent the entry of illegal aliens and drugs. Federal immigration agents should be detaining and deporting those who are arrested. Unfortunately, there are many "sanctuary" cities and states that refuse to cooperate with immigration agents.

All immigrants and foreign visitors must be vetted before they enter the country, and all illegal aliens should be deported, regardless of their age, race, health, income, and family status. We cannot allow criminals, terrorists, and people with infectious diseases to enter the country freely.

But the liberal silence is on illegal alien crimes, and violence is deafening.
